Public Notice (No. 2023-134) of the Ministry of Economy and Finance

Korea Wood Panel Association requested the Korean Government to review the need for the continued imposition of the anti-dumping duty on Plywood originating from the Socialist Republic of Viet Nam in accordance with Paragraph 1.2 and 2 of Article 70 of the Presidential Decree of the Customs Act. Therefore, the Ministry of Economy and Finance has determined to initiate the review after consultation with the Korea Trade Commission and hereby notify it in accordance with Paragraph 3 of Article 70 of the Decree.

Initiation of the Review on the Need for the Continued Imposition of the Anti-dumping Duty on Plywood originating from the Socialist Republic of Viet Nam

1. Outline of the review application

- a. Applicants: Korea Wood Panel Association.
- b. Date of application: May 4th, 2023
- c. Product subject to application: Plywood originating from the Socialist Republic of Viet Nam on which the anti-dumping duty has been being imposed by the Decree of the Ministry of Economy and Finance No.815 dated on November 6th, 2020, which later revised by the Decree of the Ministry of Economy and Finance No.882 on December 31st, 2021.
- d. Reasons for the review application: There are concerns that the expiry of the anti-dumping duty would be likely to lead to the continuation or recurrence of dumping and injury to the domestic industry.

2. Details of the review

- a. Product subject to investigation: The same as the product subject to application.

- b. Object of investigation: To examine whether or not the expiry of the anti-dumping duty would be likely to lead to the continuation or recurrence of dumping and injury to the domestic industry.
- c. Suppliers subject to investigation
 - SAVI Co. Ltd., Thanh Hung Import-Export Company Limited, Junma Phu Tho Company Limited, Cong Ty Tnhh Mot Thanh Vien Kieu Thi Junma, Yen Bai Wood Industry Company Limited, Rongjia Woods Vietnam Company Limited.
 - ※ among the suppliers, who are not selected to be investigated but voluntarily apply for the investigation, may be selected as suppliers subject to the investigation.
- d. Investigation authority: The Korea Trade Commission (KTC)
- e. Period of investigation
 - Investigation of continuation or recurrence of dumping: From January 1st, 2022 to December 31st, 2022 (if necessary, the period may be adjustable with consideration of accounting period of suppliers or of easiness of investigation.)
 - Investigation of continuation or recurrence of injury to the domestic industry: From January 1st, 2019 to December 31st, 2022 (if necessary, the period may be extended until the date of determination of injury to the domestic industry.)

3. Outline of the review procedure

- a. Date of investigation commencement: July 3rd, 2023
- b. Period of Investigation: Within six months from the date of investigation commencement (Extension of the investigation period may be made to a maximum of four months in accordance with Paragraph 6, Article 70 of the Presidential Decree of the Customs Act.)
- c. Date of determination on the imposition of the anti-dumping duty: Within one year after the initiation date of the review.
 - ※ Even if the time limit applied to the anti-dumping measure expires during the review period, the effect of such anti-dumping measure shall continue to be valid during such review period in accordance with Paragraph 8, Article 70 of the Presidential Decree of the Customs Act. And according to Paragraph 9, Article 70 of the Decree, the settlement for the review period can be followed.
