**Subject; Oral Hearing in Sunset Review of Anti-Dumping Duty imposed on imports of Elastomeric Filament Yarn from China PR, South Korea, Taiwan and Vietnam.**

Sunset Review of Anti-Dumping Duty imposed on imports of Elastomeric Filament Yarn from China PR, South Korea, Taiwan and Vietnam, was initiated on 30.06.2021 under the Customs Tariff (Identification, Assessment and Collection of Anti-dumping duty on Dumped Articles and for Determination of Injury) Rules, 1995 (AD Rules). As per Rule 6 (6) of AD Rules *“The Designated Authority may allow an interested party or its representative to present the information relevant to the investigation orally but such oral information shall be taken into consideration by the Designated Authority only when it is subsequently reproduced in writing”*.

2. In pursuance of the aforesaid provision, and the prevailing Covid-19 pandemic, Designated Authority has scheduled an oral hearing in the matter through Digital Video Conference (DVC) to be held on **10<sup>th</sup> November, 2021 at 11.30 AM**.
